1. Introduction

2. Information We Collect

Automatically collected information. Like most websites, we may collect technical data such as IP address, browser type, device information, pages visited, referring URL, and approximate location. We use Vercel Analytics to understand Site traffic and performance in aggregate.

Client project data. When you engage Clearprise for services, you may provide business data, credentials, system access, or customer information necessary to deliver the work. Handling of that data is primarily governed by the applicable client agreement and any data processing terms we agree in writing.

3. How We Use Information

We use information to: (a) respond to inquiries and schedule consultations; (b) deliver and improve our services; (c) operate, secure, and analyze the Site; (d) communicate about projects, proposals, and related matters; (e) comply with legal obligations; and (f) protect our rights and prevent misuse.

We do not sell your personal information.

4. Cookies & Similar Technologies

You can control cookies through your browser settings; disabling some cookies may affect Site functionality.
